


The grant of tuition fee waiver is based on the below mentioned documents and a “Certificate of Undertaking” provided by the students and the merit list of marks secured by these students in the admission process conducted by the Institute from Feb to Mar 2024 for admission in 2024 – 26 batch.

1. Income certificate of the family, where income of the family from all sources should not exceed INR 8 lacs for the financial year 2023 – 24.
2. PAN number.
3. Validation of income related documents by the local authority such as Block councillor, etc.
4. Self-declaration certificate that information provided is true.
5. Income proof / Economically Weaker “Letter from Officer of Sub Divisional Officer”


